Onward and Upward. Grants approach \$1 million in 2018.

Upon taking over for past CEO Larry Pejeau in the fourth quarter of 2018, I quickly realized how fortunate I was to inherit such a well-run organization. Over Larry's tenure, your Brown County Community Foundation was driven to new heights by polishing practices and procedures, aligning fundraising goals with strategic community initiatives, maintaining a sound investment portfolio, and ultimately investing more in the future of Brown County. Giving Indiana Funds for Tomorrow

GIFT VII

The BCCF received a grant of \$500,000 as part of Lilly Endowment Inc.'s seventh phase of the Giving Indiana Funds for Tomorrow (GIFT) initiative.

BCCF can use this matching fund grant to build our financial assets and support local charitable activities. At least two-thirds of the matching fund grant must be designated to support the growth of BCCF's unrestricted endowments, which over time will provide flexibility to help the Foundation meet community needs.

In 2018, BCCF chose to designate up to one-third of the matching fund grant to assist local nonprofits with current needs and charitable projects. Lilly Endowment provided 50 cents for every \$1 that these organizations raised during the matching period. The benefiting organizations are as follows:

Unrestricted funds are at the heart of our grant-making capacity and are used to award competitive grants that strengthen the community, such as supporting our pre-k scholarship program with Brown County Schools, helping to establish the Brown County Hour, starting the Access public transportation service, buying recycling equipment at Brown County Solid Waste Management District, supporting organizations like the Career Resource Center and the Literacy Coalition, sponsoring renovations at the Art Gallery, helping our first responders, and dozens of other community groups and organizations. This is a unique opportunity to **triple** the impact of your charitable giving and to support local needs and organizations by growing our endowment and increasing available grant dollars.



How it works:

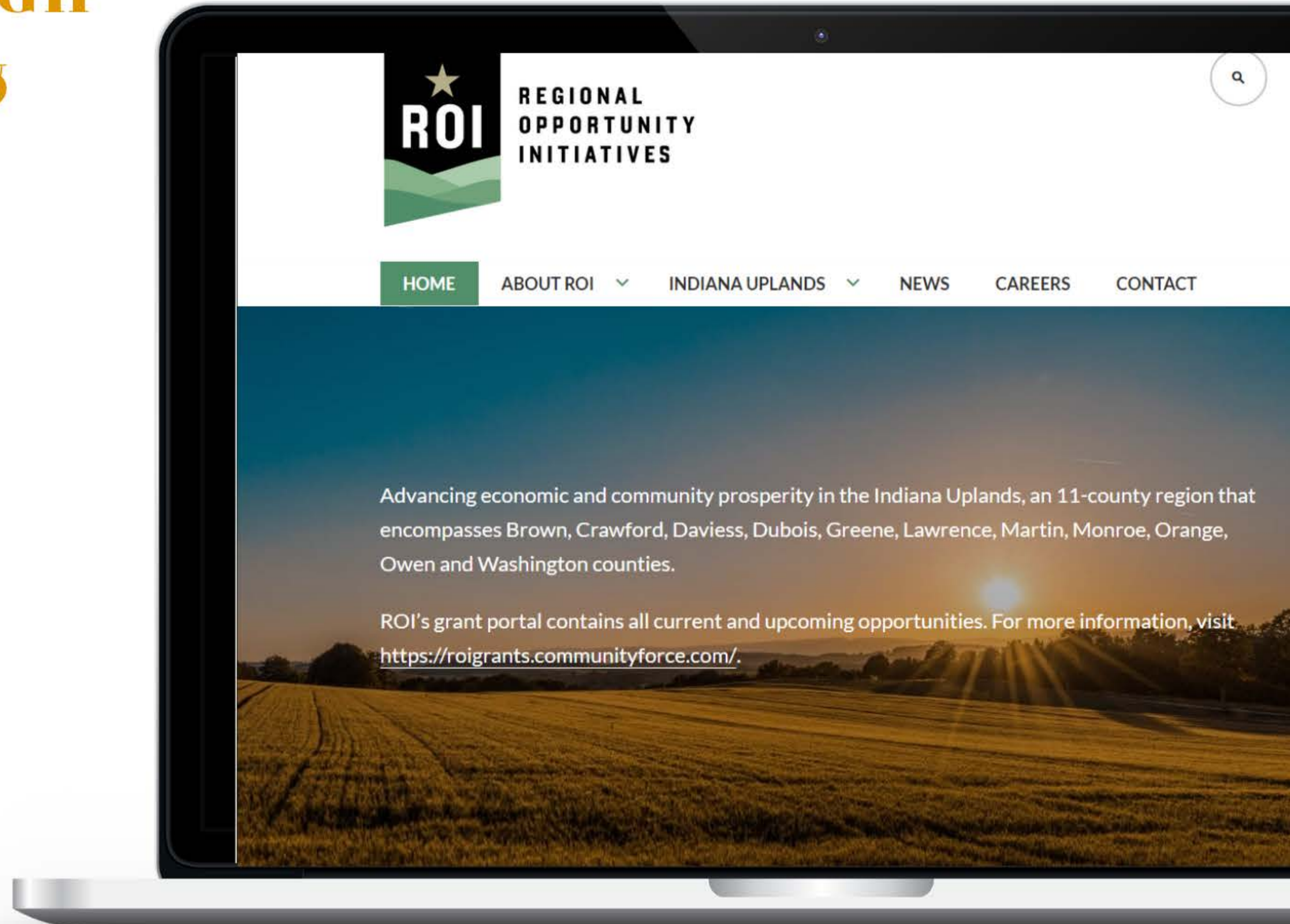
Regional Opportunities Initiative

2018 Planning Grant

A new initiative this year, Ready Communities provided Brown County with grant dollars to strategically develop a plan that builds quality of place, grows regional capacity for workforce development and attraction, and improves the attributes and amenities that make the Indiana Uplands region a desirable place to live, work, and play.

The study will be completed in 2019. Following this stage, up to \$3 million in implementation grants will be available in 2019-2020 to be used for Aesthetics and Beautification Enhancements, Connectivity Infrastructure Development, and/or Community Cohesion & Support initiatives. We are excited about the opportunity to make significant impacts in these areas of community interest. Look for the report in 2019!

Fabulous 50

Women's Giving Circle

Each of the 92 'Fabulous 50' members give \$200 per year to the giving circle. Each donor submits a cause she would like to support on a slip of paper, and three slips are drawn to identify who will vie for that year's donations. Members make pitches to the group as to why their nominee is deserving, culminating in a final vote.

A creative giving solution that will benefit generations to come.

Did you know that there are many ways to support the BCCF and other charitable organizations besides writing a check? Virtually **any** asset of value can be given to the Community Foundation. Regardless of the size of your estate, by contacting your attorney and creating or updating your will, you can provide for your beneficiaries while leaving a personal legacy which supports a cause that has meaning to you.



Write Your Will

It's one of the most important documents you'll ever sign. Wills can distribute your property, name an executor, name guardians for children, forgive debts, and more. Use will planning as an opportunity to decide what type of legacy gift best suits your estate planning goals.



Life Insurance

By naming the Foundation as the irrevocable owner and beneficiary of a life insurance policy, a donor is entitled to an immediate tax deduction on the cash value of the policy, with future premiums paid by the donor being deductible as charitable gifts.



Charitable Bequest

You can bequeath a certain dollar amount (ex. \$10,000), a particular percentage (ex. 5% of the value of the estate) or certain other property (such as a home, art collection, etc.). This is the most popular form of charitable bequest. Indeed, gifts of specific properties to charity may be uniquely appropriate bequests, both for tax and personal reasons.



Trusts

Trusts have become an increasingly popular tool in estate planning, especially in the field of charitable giving. Individuals form different kinds of trusts to:

- Avoid probate administration
- Secure income, gift and estate tax savings
- Decrease gross estate size
- Assure preservation of wealth and to protect assets from creditors
- Diminish asset management responsibilities
- Control disposition of assets to beneficiaries

2018 Lilly Scholar

Since 1998, Brown County Community Foundation has had the privilege of awarding Lilly Endowment Community Scholarships to 36 Brown County High School Graduates. This annual scholarship will pay full four-year tuition and \$900 a year for books and equipment to the Indiana public or private college of the student's choice.

The scholarships are the result of a statewide Lilly Endowment initiative to help Indiana students reach higher levels of education. Indiana ranks among the lowest states in the percentage of residents over the age of 25 with a bachelor's degree. During the first 15 years of the program, 3,629 students have received Lilly Endowment Community Scholarships statewide. Those scholars are attending 45 different Indiana colleges.

Our 2018 winner, Grace Jackson (left), received a full four-year scholarship to Butler University.

Our nonprofit partners are invited to submit compelling stories about their most dedicated volunteers. The BCCF reviews these applications and picks a select number of winners each year.

These volunteers are recognized publicly at our Annual Report to the Community where each winner will select a nonprofit to receive a \$250 grant from the BCCF. The community is the true winner, benefiting from the time and talent of all of our generous community volunteers.



John D. Rudd Community Service Award

In 2003, the Board of Trustees of the Brown County Community Foundation established the Community Service Award in honor of John Rudd's devotion and demonstrated broad-based service to his native county. This award annually honors an individual (or individuals) who have demonstrated the commitment, accomplishment, and spirit of John D. Rudd. In acknowledgment of his remarkable record of service, Mr. Rudd was the first recipient of this award. The 2018 award was given in honor of the many contributions of **Ruth Reichmann**.

Ruth's passion for the arts and cultural history, as well as historically significant structures, is extensive. She has a long and strong connection to the League of Women Voters and has been very effective in initiating and building collaborative projects by convening successful community conversations. She has been an active member of the Historical Society and started the Peaceful Valley Heritage Preservation Society, opening a fund to support the organization's activities in 2016. This group has already restored and saved the Historic County Log Jail as well as drawn considerable attention to one of Brown County's earliest artist, Henry Cross, restoring a number of his tombstones in local cemeteries.

Ruth has continually introduced professionals from the preservation field to inform and guide our local efforts. Her connections and funds have been instrumental in community projects including the research on the Historic Courthouse and the Old Town Nashville Project. She was the driving force behind the State Historic Marker located at the Bill Monroe Campgrounds and recently a State Historic Marker honoring T.C. Steele. Ruth is involved in many more projects, including the Hoosier Hills Scenic Byway and an effort to designate Old Town Nashville as a State Historic District.

More importantly to us, Ruth was instrumental in the formation of the BCCF. Working with Jon Cain, Jim Callahan, and Del Newkirk, this group approached Lilly Endowment, Inc. for the first round of their GIFT program and partnered with the Heritage Fund in Bartholomew County for mentoring and financial sponsorship. Ruth was part of the conversation and provided much of the push to form our first Board of Directors in 1994. Lilly Endowment offered a \$500,000 challenge grant and the Board accepted. Nearly \$900,000 was raised by the community and the rest is history.

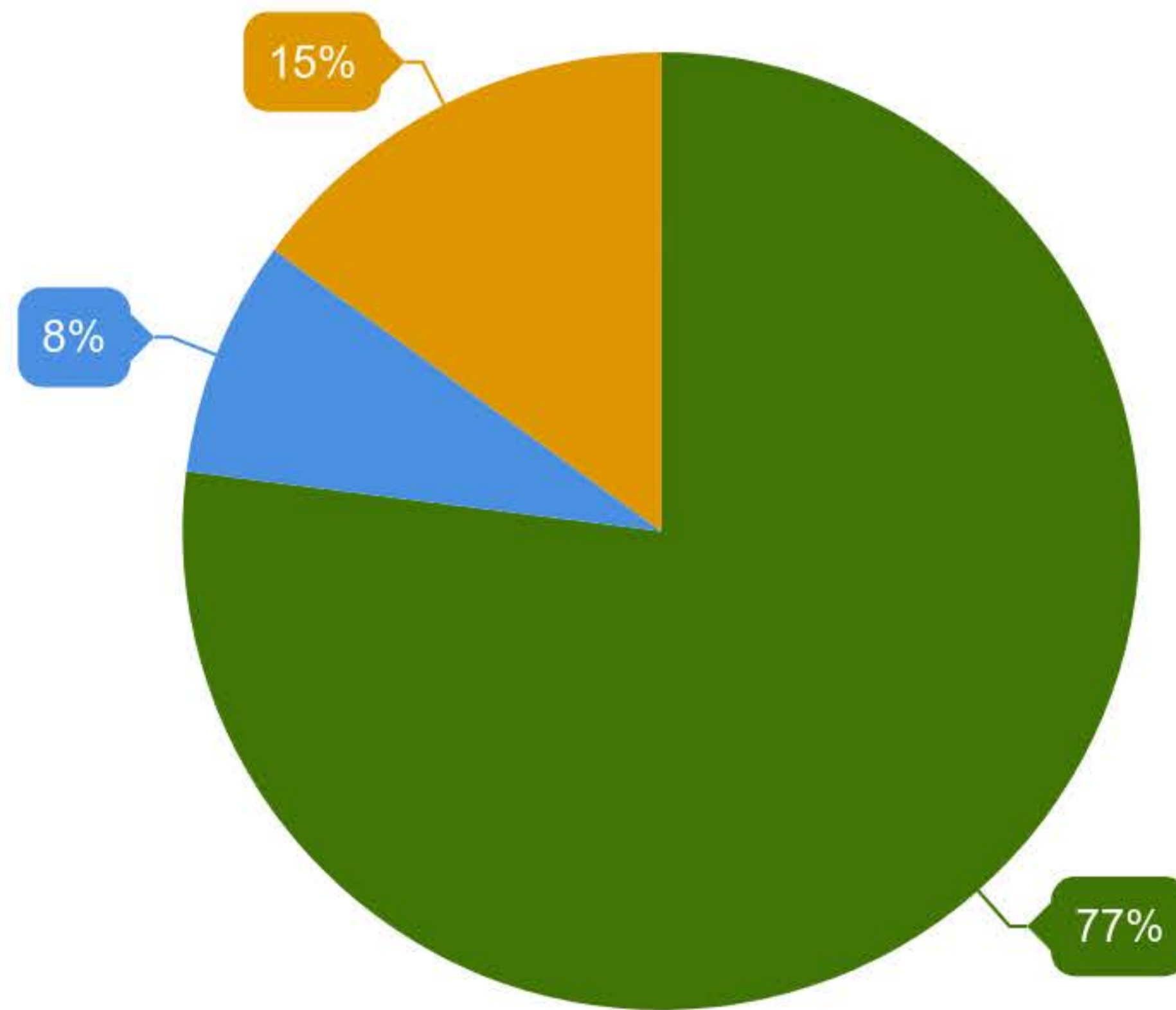

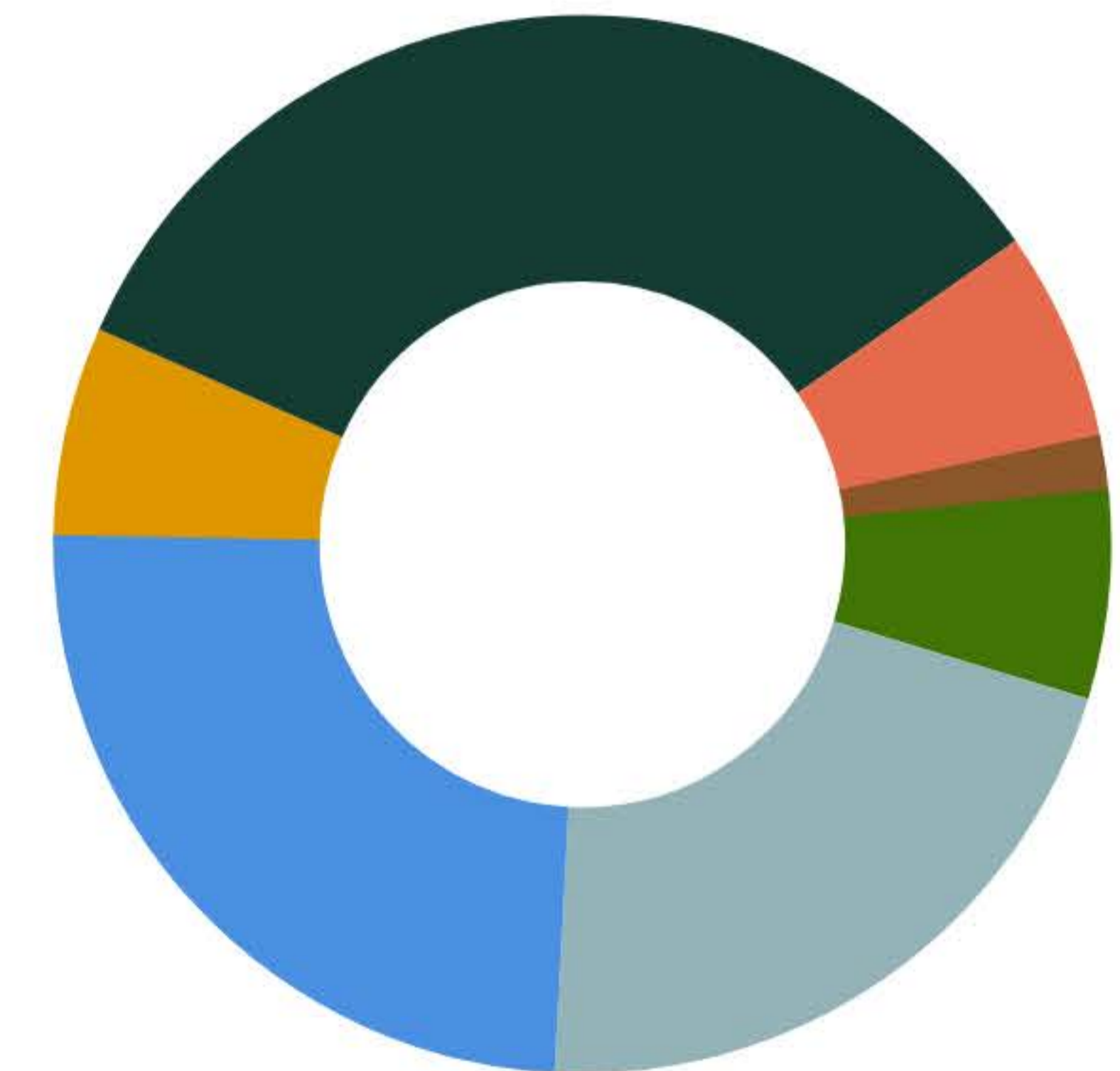
